## Disaster Recovery Small Business Grant

If you are a small business or a not-for-profit organisation in NSW and you have been directly impacted by storms and floods in February and March 2022, you may be eligible for a storm and flood disaster recovery small business grant.

This disaster recovery grant of up to \$50,000 is to help pay for the costs of clean-up and reinstatement of a small business or not-for-profit organisation's operations.

## Smart and Skilled - Add a Qualification to the NSW Skills List



### Smart and Skilled NSW Skills List – v12.3

The NSW Department of Education is inviting industry to add qualifications to the NSW Skills List for Smart and Skilled Funding by 5pm Friday 8th April 2022.

The Skills List identifies the vocational education and training (VET) qualifications eligible for a government subsidy under the Smart and Skilled program. The purpose of this process is to ensure the NSW Government's Smart and Skilled program is helping to meet the skills needs of NSW.

## Boosting Apprenticeship Commencements Wage Subsidy Extended

[Boosting Apprenticeship Commencements](#) (BAC) wage subsidy supports employers of any size to take on new apprentices or trainees. The subsidy has been popular with employers, and there has been a significant increase in apprenticeship and traineeships numbers since the wage subsidy was introduced.

Enrolments for the BAC wage subsidy, which provides employers with 12 months of wage subsidy support, are being extended to the end of the 2021-22 financial year (30 June 2022).

Any business that receives the BAC wage subsidy will also then be eligible for extended support through the Completing Apprenticeship Commencements (CAC) wage subsidy for the second and third year of a Boosting Apprenticeship Commencement-supported apprenticeship. ## Skills Reform: Improving VET delivery to secondary students – Feedback Survey

The Australian Government through the Department of Education, Skills and Employment (DESE) is seeking input to understand what stakeholders think about VET for secondary students and the opportunities to strengthen it. Two feedback forms have been developed for:

These feedback forms outline some of the key challenges and issues identified with VET for secondary students based on previous reviews. They include questions to help facilitate input on how to improve VET for secondary students and how to shape the National Strategy.

## NCVER: The Latest in Apprentice and Trainee Outcomes



The latest National Centre for Vocational Education Research (NCVER) findings highlight the outcomes of apprentices and trainees aged 18 years or over who completed an apprenticeship or traineeship during 2020. Employment outcomes for apprentices and trainees grew to 94% for trades and 88.4% in non-trades, representing an increase of 2.5% and 3.5% respectively from 2019.
