Successful Mid-North Coast Local Industry and Schools Forums

More than 150 employers and schools attended the Industry and Schools Forums in Coffs Harbour, Kempsey and Taree earlier this month. The forums provided valuable networking opportunities for employers, career advisers, principals and teachers. Industry representatives from various sectors also had the opportunity to discuss their available positions and current skills shortages.

Laura Matthews, Dairy NSW, Mid-North Coast workforce attraction and retention officer, highlighted the multiple programs available for young people to get into agriculture, including the AgCAREERSTART program.

Additionally, the forums provided an opportunity to improve employers' awareness and understanding of School Based Apprenticeships and Traineeships (SBATs), highlighted the benefits of Vocational and Education Training (VET) and the advantages of introducing young people to work and skills.

Sara Morgan illustrated the benefits of VET. As a young person, she worked at the

Currumbin Wildlife Sanctuary, which led to her studying Certificate IV in Veterinary Nursing and working as a vet nurse. Sara then decided to pursue her passion for wildlife by undertaking a Certificate III in Captive Animals. Sara believes that her VET qualification and practical training at Currumbin Wildlife Sanctuary were necessary to understand what she wanted to do as a career and in developing her skills in handling and treating wild animals.

AFAM ITAB would like to thank the Mid-North Coast Training Services NSW team for coordinating the forums, particularly Erin Lute and Sam Palise from Regional Industry Engagement Partnerships program. Thanks also to Lisa Giammarco from the NSW Public Sector ITAB and the other ITABs who played an essential role in bringing together Mid-North Coast employers from across various industries.

Skills List Additions – Applications Close 26 May 2023.

Reminder: opportunity to apply for qualifications to be added to the NSW Skills List.

The NSW Government is inviting applications for qualifications to be added to the NSW Skills List. **Applications are open until Friday, 26 May 5pm.**

The Skills List identifies the vocational education and training (VET) qualifications that are eligible for a government subsidy under the [Smart and Skilled](#) program. The Skills List is reviewed twice a year to ensure it meets the changing skill needs of industry.

AFAM has identified all the [qualifications that are not currently on the NSW Skills List](#), for the industries we work with. If you see reason why any of these qualifications should be on the list and therefore funded under the Smart and Skilled program, please submit an application.

How to submit an application

The application must be submitted by [completing the NSW Skills List Addition online form](#).

Before completing an application, please ensure that the proposed qualification is not already on the [NSW Skills List](#).

How the applications are assessed

From 2023, the Department is progressively introducing a data-driven process for reviewing the Skills List. This annual process uses internal and external data sources, in addition to stakeholder feedback, to identify qualifications for potential addition to or removal from the Skills List. In assessing applications, the NSW Department of Education will follow the new [NSW Skills List Management Policy - Smart and Skilled](#).

The Department will consider the following criteria in their assessments of qualifications for addition or removal from the Skills List.

- **Industry demand:** Evidence that employers need workers with this qualification to fill labour market gaps / address skill shortages.
- **Student outcomes:** Evidence that undertaking the qualification will lead to either an immediate employment related benefit or provide good career prospects in the near future with a clear pathway through further study.
- **Disadvantaged student participation:** Evidence that the qualification supports training participation by disadvantaged cohorts (First Nations students, students living in low socioeconomic areas, or students with disability).
- **Target specific cohort:** The qualification targets specific cohorts such as First Nations students and provides an employment, personal, social or cultural benefit.
