AFAM attended a number of national Industry Reference Committees (IRCs) for the Agriculture, Food and Animal Management industries this month, which are likely to be the final meetings in the national AISC and SSO program. Supported by Skills Impact, IRCs have been instrumental in the work of developing and reviewing training packages over the past six (6) years. The 67 Industry Reference Committees and six Skills Service Organisations under the current industry engagement system will be replaced by an industry cluster program in January 2023.

Over the last 18 months of AFAM operation, we have been able to provide IRCs with updates on industry conditions in NSW. This has been particularly important given the impacts of floods and mouse plagues in NSW during this time, on top of the pandemic and bushfire situations.

AFAM looks forward to working with the industry cluster program and would like to extend its thanks to IRC members and Skills Impact for their contributions and their role in ensuring that training packages meet the needs and concerns of employers, employees, training providers and people seeking qualifications.

Engagement Activities

The Amenity Horticulture, Landscaping, Conservation & Land Management (AHLCLM) Industry Training Advisory Committee Meeting was held by AFAM ITAB at the end of August. The Committee members play a vital role in providing AFAM with information on skill needs, issues and priorities for their industry sectors in NSW.

The AHLCLM Committee discussed a range of topics including biosecurity, workforce shortages, attracting new entrants, skill needs, technology and the training delivery opportunities and challenges in NSW. An update on the Varroa Mite situation and impacts to the beekeeping industry and horticultural sectors was also provided to the Committee.



AFAM attended the <u>FarmLink</u> Open Day which was held at the Temora Agricultural Innovation Centre, Friday 9 September. The Open Day was a big success with over a hundred farmers coming from all around Southern NSW for a day of presentations, displays and workshops by researchers, scientists, consultants and industry leaders.

The event enabled attendees to find out more about the current projects and trials such as the Crop Projection Trial, <u>Cool Soil Initiative</u>, <u>Future Soils</u> and <u>Pasture trial</u> being run by FarmLink and its partners. There were also presentations on biosecurity, specifically foot and mouth disease and lumpy skin disease, off-farm investment, office efficiency and a live spray drone demonstration.

Smart and Skilled Update

The Smart and Skilled application process **opens 1 November 2022** and will determine which registered training organisations (RTOs) are suitable for a Smart and Skilled contract and allocations for the 2023-24 financial year. RTOs seeking to enter the government-subsidised vocational education and training market in NSW are also being invited to apply.

The NSW Department of Education is conducting a survey to learn more about the extent and underlying causes of skills shortages in NSW, especially in regional areas. Jobs and Skills Summit Outcomes



The Federal Government has released the <u>Jobs and Skills Summit outcomes</u> from the recent Jobs and Skills Summit, which saw Australians coming together to work constructively on the challenges and opportunities facing the Australian labour market and economy.

As a result of the consensus reached at the Summit, immediate actions will be taken to support building a bigger, better trained, and more productive workforce – with the aim of delivering more secure jobs with growing wages, boosting incomes and living standards and creating more opportunities for more Australians. The outcomes document addresses immediate actions, areas for further work and complimentary existing commitments in the following areas:

- · a better skilled, better trained workforce
- · addressing skills shortages and strengthening the migration system
- boosting job security and wages, and creating safe, fair and productive workplaces
- promoting equal opportunities and reducing barriers to employment
- · maximising jobs and opportunities in our industries and communities.

Regional Youth Investment Program: Our Region, Our Voice



Applications are now open for the \$40 million <u>'Our Region, Our Voice' - Regional Youth Investment Program</u>. The program provides grants from \$150,000 to \$3 million for projects that aim to address the unique challenges encountered by regional youth and maximise local opportunities. The objective of the Investment Program is to genuinely reflect the needs and aspirations of regional young people in NSW to:

- 1. learn, work and achieve in regional NSW
- 2. be mentally and physically healthy, safe and thrive in their communities
- 3. explore their creativity, collaborate with other teams, develop a sense of achievement and feel socially and culturally connected to their communities
- 4. have transport and digital connectivity solutions to access training, work services and recreational activities
- 5. be place based and reflect the diversity of young people's needs across regional NSW.

The Office for Regional Youth conducted a significant youth research project consulting with almost 2,000 young people across regional NSW (<u>Regional Youth Insights report (nsw.gov.au)</u> and will ensure that funding is directed towards initiatives that young people want and need to live their best lives.
