Following strategic revisions of the AHC Training Package by unit sector, several qualifications and skill sets require updating to include the improved units.

Skills Insight is seeking comment from those who may be impacted by the replacement of the units so that disruptions can be minimised. These updates are not to change the intent of the qualifications, simply to include units already consulted on with stakeholders to better meet skills needs.

Below is an updated version of Certificate IV in Conservation and Ecosystem Management as well as a summary of the updates made to units within it.

Packaging Rules

To achieve this qualification, competency must be demonstrated in:

- 12 units of competency:
 - 2 core unit plus
 - 10 elective units.

Elective units must ensure the integrity of the qualification’s Australian Qualification Framework (AQF) alignment and contribute to a valid, industry-supported vocational outcome. The electives are to be chosen as follows:

- at least 3 units must be selected from Group A
- remaining units may be selected from Group A or B or C and up to 4 units may be selected from any currently endorsed Training Package or accredited course
- Elective Group C can only be selected if required as a prerequisite.

Where First Aid training is required, the current unit must be imported using the import rules above.
