In this role, these individuals are responsible for ensuring workplace processes and operations comply with the legislative, regulatory and quality requirements of a controlled growing, licensed medicinal cannabis site. They also use their knowledge and skills to plan for future work activities, solve problems, and take responsibility for others.

No licensing, legislative or certification requirements apply to this qualification at the time of publication.
