Engagement Activities

At the NSW Oyster Conference, the Minns Labor Government launched the NSW Aquaculture Vision Statement which is a joint industry and government initiative to double the farm gate value of the NSW aquaculture sector to \$300 million by 2030.

Key to delivering this increased value will be industry and government support initiatives including:

- Managing oyster industry risk through a breeding program, plus alternate species
- Innovative research at DPIRD research stations and with partners
- Opening up new areas for marine aquaculture (mussels, oysters, algae)
- Promoting the environmental benefits of aquaculture e.g. algae, oysters and mussels all take up excess nutrients and help improve water quality
- Streamlining aquatic biosecurity rules to facilitate access to interstate spat

supply

- Protecting and enhancing water quality
- Providing opportunity for Aboriginal people to participate in aquaculture businesses.

The Minister for Agriculture and Regional NSW, Tara Moriarty, addressed the conference reflecting on the importance and strength of the NSW oyster industry, "These past few years have been tough for oyster farmers with NSW estuaries having suffered from storms, floods, harvest area closures, disease and climate change impacts.

"Despite this, the increasing output of produce highlights the strength of the industry and the people who work in it."

A highlight of the conference was the opportunity to visit a local oyster farm at Sandfly Alley, Port Macquarie where we were able to see firsthand the type of work that takes place. Stewart and Ewan Bale conducted demonstrations on different machinery, discussed the benefits and pitfalls of working with different machinery, and talked about how the oyster farm responded to repeated disasters such as storm damage and the catastrophic floods in 2021.

NSW Skills List updated

The NSW Skills List and Smart and Skilled Prices and Fees schedule have been updated. This update covers changes because of:

- qualifications added to the NSW Skills List
- · updates to training packages*
- updates to Vocational Training Orders (VTOs)
- ASQA extensions to qualification transition periods
- price indexation of 2% for full and part qualifications.

NSW Grants, Opportunities and Scholarships

The following grants, opportunities and scholarships are available to employers and vocational learners. Follow the links for more information.

<u>Aboriginal Business Advisory Initiative</u>: support for existing Aboriginal owned and operated businesses to grow and diversify their business.

<u>Barranggirra</u>: to provide end to end support for Aboriginal and Torres Strait Islander learners through culturally appropriate mentoring to ensure successful retention and completion of training and improved post-training employment outcomes.

Elsa Dixson Aboriginal Employment Grant: the grant adopts a number of strategies to

develop and support First Nations people through the creation of training and employment opportunities.

<u>Free Training for Veterans</u>: to broaden their career opportunities and help transition to civilian life after service, veterans and their partners will have access to free training.

<u>Free Workshops: Supervising your apprentice or trainee</u>: free workshops for employers and supervisors of apprentices or trainees in the workplace held across NSW.

OCHRE Opportunity Hubs: aim to provide First Nations young people with the confidence and knowledge to follow a supported pathway between school and further education and/or employment through partnerships with schools, coordination of local opportunities, mentoring, support and more.

Resources to Assist in Supervising Your Apprentice or Trainee: a series of videos and resources are available.

Other Grants and opportunities:

<u>Free Support to Help Create Mentally Healthy Workplaces</u>: SafeWork NSW has a range of programs, tools, and resources available to help on the journey to create mentally healthy workplaces.

Food Rescue Rebates

The NSW Environment Protection Authority (EPA) is working to reduce good quality food suitable for human consumption from being disposed to landfill. The rebates are part of a suite of organics programs available to support NSW to halve organics waste to landfill by 2030.

Amount: Up to \$2,000 per rebate with a total funding pool of up to \$800,000 Status: Open, ongoing until 30 June 2027, until funding is expended, or at the EPA's discretion.

Seafood Innovation Fund - The NSW Government is offering low interest loans up to \$500,000 to assist commercial fishers and aquaculture farmers to identify and address risks to their business, improve permanent assets and infrastructure, ensure long term productivity and sustainable use of the marine, estuarine and land-based environment.

Seafood Innovation Fund loans are available to businesses within the seafood sector in NSW.

Amount: Loans are up to \$500,000 for 100% of the net, GST exclusive cost of eligible works.

Status: Open, until funding is expended.

Carbon on Country Partnerships EOI

The Carbon on Country initiative will support NSW Aboriginal organisations to own and manage carbon projects that deliver cultural, environmental, economic and social outcomes alongside carbon abatement. The grant is targeted towards NSW Aboriginal organisations and Traditional Owner groups that own the land the project will be implemented on.

Amount: From \$20,000 to \$250,000

Status: Open. Closes 24 October 2024, 11:00pm.

Living Carbon Grants

NSW Government is investing \$5 million in Living Carbon grants to assist eligible applicants in delivering carbon abatement through planting projects in 3 regions in NSW:

- the Riverina Local Land Services region
- the North Coast Local Land Services region
- the MidCoast Local Government Area.

Amount: Successful applicants will receive up to \$200,000 of grant funding, and the landholder is expected to commit funding and/or in-kind contributions to complete the

project.

Status: Open. Closes 30 April 2024.
