## **Smart and Skilled Update**

The NSW Government Smart and Skilled program aims to help people get qualifications in in-demand skills and industries. Qualifications eligible for government subsidy under NSW Smart and Skilled are on the <u>NSW Skills List</u>. If there is a qualification that is currently not funded under Smart and Skilled and you believe it should be funded, please let AFAM ITAB know as we can support your application to have the qualification added to the list.

#### Targeted Priorities Prevocational and Part Qualifications Funding Now Open

The Targeted Priorities Prevocational and Part Qualifications (TPPPQ) Program funds the delivery of part qualifications that meet local industry business and community needs. Funding is now open and is directed at priorities groups and industries.

Employers are encouraged to work with their Smart and Skilled RTOs so they can begin negotiating training with the relevant Training Services NSW regional office(s) and submit applications seeking funding for part qualifications delivery.

Funding will be directed to priority groups and industries as per the 2024-2025 Smart and Skilled Targeted Priorities Prevocational and Part Qualifications Program Funding Priorities.

AFAM ITAB will be happy to assist with facilitating an introduction to your local Training Service NSW office and Smart and Skilled RTO. The budget for this program is limited and the funding is not guaranteed.

#### **AgSkilled**

The <u>AgSkilled</u> program is administered under NSW Smart and Skilled, with agriculture as a priority sector. Funded training is available to primary producers, onfarm staff and industry professionals for part qualifications focused on agricultural tasks and skillsets.

# ANZSCO Review - Round 4 Consultation Closing

The fourth round of consultation on the Australian and New Zealand Standard Classification of Occupations (ANZSCO) is closing soon.

Managed by the Australian Bureau of Statistics (ABS), the ANZSCO describes and categorises occupations within Australia and New Zealand, providing a framework for data that informs decision making at all levels of government in Australia.

The fourth round of consultation invites feedback on the ABS's proposed changes,

which have been developed in response to rounds one, two and three of consultation.

#### Round four is open until 6 September 2024.

## **Changes for Australian Apprentices**

The Department of Employment and Workplace Relations, in partnership with Australian Apprenticeship Service Delivery Providers (Providers), is now offering enhanced support to better assist apprentices and their employers throughout the apprenticeship journey, from its inception to successful completion.

Targeted support is available for those in need, from the pre-sign-up stage until the conclusion of the apprenticeship. This includes strengthened mentoring services for:

- · Women in male-dominated trades
- First Nations Australian Apprentices
- · Australian Apprentices with disabilities
- Australian Apprentices located in remote areas
- · Other apprentices at risk of not completing their apprenticeship
- Employers Requiring Support

Services such as pastoral care, career guidance and peer support networks are available for apprentices and assistance to understand their roles and responsibilities, implement strategies and connect to training and support for employers.

## Spring Equine Internship Program

Registrations are now open for the Spring Intern Program offered by Silverdale Academy in conjunction with TAFE NSW. This is a fully funded 6-week intern program including practical experience at Silverdale Farm. The course commences **23 September to 22 November 2024**.

The program is designed to introduce students to the career opportunities within the horse industry and encompasses breeding, spelling and agistment, racing, horse care, health and welfare, safe handling practices and general farm duties.

Interns will be recognised as completing the following Nationally Recognised Units:

- ACMEQU212Handle horses safely
- ACMEQU217Load and unload horses
- ACMEQU313Work safely in equine workplaces
- BSBCMM211Apply communication skills

Silverdale Academy is a not-for-profit industry initiative established to provide access to training which is otherwise not available. It receives NSW Government funding for some of its programs, and is otherwise supported by industry contributions.



## Elsa Dixon Grant Now Open

The Elsa Dixon Aboriginal Employment Grant promotes diversity, innovation and service responsiveness in the NSW workforce. The Grant contributes funding towards the salary and development of First Nations employees in NSW Public Service Agencies or Local Government Authorities promoting education, employment and training outcomes for First Nations people.

There are several grant elements available including:

- School-based Apprenticeships and Traineeships (SBATs) \$10,000 one off payment to support SBATs.
- Adult Apprenticeships and Traineeships (AAAT) up to \$40,000 to support the
  creation of employment of an AAAT. Learners must be a minimum 21 years of
  age to be eligible.
