<p><b>Tree Felling Project</b></p> <p><b>Start date:</b> 30 June 2023 <b>Completion date:</b> 1 May 2024</p> <p><b>Prioritisation:</b> Fast-track <i>To discuss and find solutions that will make sure the units can be safely delivered and assessed before the teach-out period expires. In devising solutions, consideration will be given to safety standards, accessibility of resources, competency development and training resources.</i></p>	<p>Using a chainsaw to fell trees is a crucial skill in forestry operations, agriculture and arboriculture, as well as in emergency events like storms, cyclones and bushfires. Manual tree felling skills are essential for removing trees in locations or positions that make the use of large machinery unviable.</p> <p>These skills are described in three units of competency which specifically outline the number of trees required to be felled in order to demonstrate competence at a basic, intermediate and advanced level.</p> <p>Some training providers have indicated that the number of trees required at each unit level has an impact on their ability to deliver training, as practice trees can be difficult to source outside of a forestry environment. It is crucial that these units are accessible to train, so that everyone who performs tree felling work can access formal training.
