


Having identified the necessary 'competencies' required to undertake the Certificate IV in Veterinary Nursing, which may be attained in a number of ways, this skill set is designed to provide individuals with the foundational skills in animal care and handling to meet the entry requirements for the Certificate IV, as well as encourage training organisations to contextualise general animal care and handling units to the specific needs of the veterinary context.
